# Boom A Rang ATV Club

# **By-Laws**

#### Article 1 - Name

The organization shall be known as the Boom A Rang ATV Club.

### **Article 2- Objectives**

To Explore, expand, and participate in on and off road riding opportunities. To foster relationships with friends and all terrain vehicle enthusiasts.

### **Article 3- Membership**

Club membership shall be open to all ATV/UTV riders and enthusiasts. Membership in the organization shall be determined on a non-discriminatory basis, without regard for age, sex, race, religion, or national origin.

Membership votes shall be determined as follows by membership in the organization:

- 1) Individual One Vote
- 2) Family Membership Two Votes

Annual membership dues for individual and family membership will run from calendar year January to January.

Members may be terminated from the organization for good cause as determined by the 5 club officers or subject to suspension period, as a result of the charges against that individual.

## **Article 4- Membership Meetings**

- 1) Regular meetings shall be held on a designated day and at a location determined by the membership
- 2) The president shall preside over all meetings. In the absence of the president, the vice president shall preside over the meeting. If both the president and the vise president are absent, the secretary shall preside over the meeting.
- 3) Business of the club will be approved with 50% of the members present at a club meeting voting for approval.
- 4) All business shall be conducted by a motion from the floor, with a show of hands vote, unless a motion is made to have a secret ballot vote, except in the election of officers.5) Membership meetings may be called by the president, by majority of the officers, or by 50% of members in good standing by filing a written call request to the president and secretary of the club. The request shall state the date, time, location, and purpose of such meeting a minimum of 48 hours prior to the meeting.

#### **Article 5- Election of Officers**

- 1) The governing body of the organization shall consist of the president, vice president, secretary, treasurer, and events coordinator, which shall be nominated and elected by the members in good standing.
- 2) Nominations shall take place at the January meeting and any person nominated must be notified and accept the nomination of such office.
- 3) 3) Elections shall be conducted at the January meeting, and newly elected officers shall take office at the start of the February meeting
- 4) The term of office shall be for a period of two (2) years. There is no limit as to the number of terms and individual may hold office.
- 5) All elections shall be by secret ballot except in the case of an unopposed candidate at the close of the nominations for the position.

#### **Article 6- Duties of the officers**

- 1) The president shall preside over all meetings, and shall cast the deciding vote in case of a tie by the remaining four officers.
- 2) The vice president shall fulfill the duties of the president in his/her absence.
- 3) The secretary shall keep legible records of all regular, special meetings, and have those records readily available. The secretary shall read the minutes of all meetings of all meetings at the regular meeting since the last reading. The secretary shall maintain a register of members attending meetings of the organization for a period of 5 years. All minutes of the meetings will be e-mailed to all members in good standing.
- 4) The treasurer shall keep accurate, up to date financial records for the organization, make reports of all financial activities on a monthly basis, and collect monies of the organization for dues, fundraisers, etc., and disperse as directed by the organization, or it's officers. The treasurer shall keep the records in such order that they may be audited or turned over to the officers for audit within a 24 hour period.

### **Dispersing of funds**

Checks can be signed by the Treasurer, and/or President, or other designated person of good standing within the club as authorized signer on bank account
